In India, GTU is the first affiliating-type technological university, which developed its own Student Startup policy.

GTU has formed two Forums viz Young Entrepreneurs for S4 (YES4) & Student Entrepreneurs for S4 (SES4) to give a platform to all the Young & Student Entrepreneurs in the state. Those who register with these Forums will be able to avail various facilities like capacity building workshops, networking, etc. organized by GTU Innovation Council (GIC) and S4. As the Forums grow in size, the university may start organizing an Annual National Student Start-up Festival every year. Members of YES4 may be able to mentor aspiring student startups. YES 4 may develop a close bonding among students, student entrepreneurs and successful entrepreneurs.

Student entrepreneurs, who are either perusing their courses in Colleges, affiliated with GTU, or have passed out from such Colleges during the past three years can be member of SES4 network. Other start-ups apart from this can be member of YES4. YES4 and SES4 will be able to create a knowledge network of like-minded entrepreneurs.
