Have insights on the Global and National Start-up Ecosystem and patent filing mechanism. Mr. Amit Patel started the first session with brief introduction about Intellectual Property Rights (IPR). In the current knowledge-driven, private sector oriented economic development paradigm, the different types of intangible assets of a business are often more important and valuable than its tangible assets. It usually gives the Creator an

Afterwards the session was continued by discussing the examples of intellectual property, which are listed below: -

- Scientific works
- Performances of performing artists
- Logos/Symbols
- Company marks
- Product names
- Bottle designs
- Manufacturing Regions

A new way of doing something, or offers a new technical solution to a problem is called Patent. Move ahead, there was discussion on Criteria of Patentability. Any Invention has to follow the principle of “3 I”:

1. Innovativeness (Novelty)
2. Inventive Step (Non-obviousness)
3. Industrial Utility (Usefulness)

Next topic was New Invention. It means any invention or technology which has not been anticipated by... Next was, Don'ts to get a Patent. STAY AWAY FROM: Publications, Award Competition, Public Display, Public Working. Move further, there was topic of use of Patent Information. There was also discussion about Student Start-up and Innovation Policy(SSIP), Key Provisions of SSIP for Innovators:

1. **PoC Support/Pre Seed Grant** - Maximum Financial Support @ Average **Rs 2,00,000/-**
2. **IPR Support** – Average **Rs. 25,000/-** per National Patent Filing Including Government Fees.

Next slide was Process for Patent Filing Support. As per the provisions of SSIP, here by GTU is creating mechanism to disburse Average Rs. 25,000/- per National Patent Filing Including Government Fees. Mr. Amit Patel had discussed about Functions and duties of Facilitators, Essential Collected Data of GTU IP Facilitator, Government fees for Patent Filing and Ownership of IPR.

And at last, Process Flow for Patent Filing of an Innovation under GTU SSIP IP Filing Facilitation Scheme.

After its declaration, based on the experience gained over a period of time for implementation of the scheme, GTU may amend certain aspects of the scheme for proper utilisation of the fund. And Mr. Amit Patel had discussed one last topic which was Ideal/Suggested disbursement of Rs. 25,000/-.

1. Payment of Govt Fees for Patent Application (Rs 1600) & Request for Examination (Rs 4000) (For Natural Person, Online Mode) - RS 5600/-
2. Patentability & Prior Art Search Report Drafting and Filing of Complete Patent Specification – RS 19,400/-
